Articles of Incorporation

THIRD: The purpose for which the Corporation is formed is exclusively for pleasure, recreation and other nonprofit purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code of 1986, as amended (the "Code"). (This reference and all further references herein to any Section of the Code shall be deemed to include all regulations promulgated thereunder and any corresponding provision of any future United States internal revenue law and the regulations thereunder.) To the extent not inconsistent with the foregoing, the Corporation's purpose shall include, but not be limited to, the following:

- (a) To promote the ideals of scouting and the rank of Eagle Scout, including, courage, loyalty, honor, and service;
- (b) To promote fraternity, scholarship, leadership, high moral standards, and recreation among its members and all of Epsilon Tau Pi Fraternity (the "Fraternity") in accordance with the principles, traditions and rituals of the Fraternity;
- (c) To purchase, improve, operate, manage, own, use or lease, in whole or in any part, any building or other structure located on real property owned or leased by the Corporation, or any other person or entity for use as a chapter house by members of the Fraternity;
- (d) To fulfill any other purposes permitted by Chapter 1702 of the Ohio Revised Code as may be deemed appropriate by the Board of Directors of the Corporation.

SIXTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(7) of the Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code, or the corresponding section of any future federal tax code.

SEVENTH: Upon the dissolution of the Corporation, all assets remaining after paying or making provision for the payment of all of the liabilities of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
